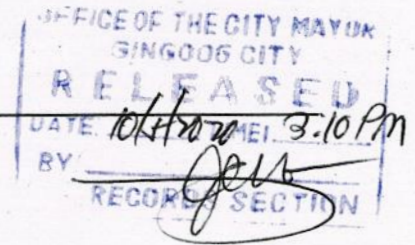

**AN ORDER CREATING A LAWS AND REGULATIONS INSPECTORATE AND MONITORING TEAM**

**WHEREAS**, the Sangguniang Panlungsod of Gingoog has through the years passed numerous laws/ordinances, and regulations, fully implemented by the executive department, for the development of the city and the improvement of the quality of life of the general populace;

**WHEREAS**, notwithstanding the full implementation of laws and regulations, there are still a few, be it establishments, offices or individuals, who fails in its compliance;

**WHEREAS**, there is a need to increase the inspection and monitoring of the implementation and compliance of laws and regulations in the city, particularly in the field of health and sanitation, in order to prevent and or mitigate the spread of the Coronavirus or Covid-19 Pandemic;

**WHEREAS**, it is crucial to create a laws and regulations inspectorate and monitoring team;

**WHEREAS**, Section 16 of the Local Government Code of 1991 (R.A. 7160) states that, "Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

**NOW, THEREFORE, I, ERICK G. CAÑOSA**, Mayor of Gingoog City, Province of Misamis Oriental, by virtue of the powers vested in me by law do hereby order the following:

**Section 1. CREATION OF THE LAWS AND REGULATIONS INSPECTORATE AND MONITORING TEAM.** It is hereby ordered to create a laws and regulations inspectorate and monitoring team to ensure the proper implementation and compliance of all laws and regulations in the city.



**Section 2. TEAM COMPOSITION.** The team shall be composed of the following:

**Section 3. DUTIES AND FUNCTIONS.** The inspectorate and monitoring team shall perform the following duties and functions:


a.) Conduct inspection and monitoring of government offices including the city public market and other government economic establishments (e.g. Tatak Center, Pahayahay sa Pantalan), the city landfill, and other business establishments within the city of Gingoog to determine compliance with existing laws and regulations; and

b.) Submit a regular report to the City Mayor.

**Section 4. REPEALING CLAUSE.** Any Executive Order not consistent with this Order is hereby amended or repealed.

**Section 5. EFFECTIVITY CLAUSE.** This order shall take effect immediately.
